## Action

- 1. Closed the Victoria office (473.53 m2) in March 2019 to significantly reduce GHG emissions, including reduced travel between Victoria and Vancouver.
- 2. Continued to support flexible work arrangements that will reduce the draw on energy resources at the office and reduce travel and related emissions to and from work.
- 3. Continued to move towards digital files to reduce paper consumption.



Briefly describe plans your organization has for continuing to reduce your GHG emissions in future years:

- Continue to promote the use of video conferences and conference calls for meetings that would typically require travel.
- Continue digitization of records.

Describe any actions your organization took during 2019 to strengthen its ability to manage the likely effects of climate change in the coming years and decades (e.g., have assessed whether increased frequency of extreme weather events and/or long-term changes in climate will affect your organization's infrastructure, its employees and/or its clients.)

Continued engagement in emergency management planning initiatives with MTAC - Tourism Policy Branch, Emergency Management BC, and with tourism industry partners to enhance emergency preparedness and response efforts necessary to address tourism impacts resulting from natural disasters and emergencies. ## **Retirement of Offsets:**

In accordance with the requirements of the *Climate Change Accountability Act* and Carbon Neutral Government Regulation, Destination is responsible for arranging for the retirement of the offsets obligation reported above for the 2019 calendar year, together with any adjustments reported for past calendar years. The Organization hereby agrees that, in exchange for the Ministry of Environment and Climate Change Strategy ensuring that these offsets are retired on the Organization's behalf, the Organization will pay the associated invoice to be issued by the Ministry in an amount equal to \$25 per tonne of offsets retired on its behalf plus GST.
