These figures do not account for all visitors to BC, as domestic visitors are excluded as well as international visitors who cross Canada Customs outside BC, yet still travel to BC. Likewise, customs entries include visitors that cross Canada Customs in BC, but who continue on to other provinces.

3. 2018 data from major airports (including YVR) are estimates from the new automated Primary Inspection Kiosks, 2017 data is based on paper customs entry cards; use caution when interpreting year over year changes.
