^{*} In April 2022, Statistics Canada changed the mode of transport classification for international ferry ports to align with UNWTO standards. In addition, due to advances in data collection via the E63-1 form at water ports, trip lengths of ferry/cruise passengers are no longer comparable to previous years. As a result of these methodology changes, year-over-year comparisons for U.S.A Same Day and Overnight visitation are not provided.
