VALUE OF TOURISM 2014

A Snapshot of Tourism in BC*

OVERVIEW

This publication provides a snapshot of the economic value of tourism to British Columbia in 2014. It is also a complementary piece to the full 'Value of Tourism in British Columbia: Trends from 2004 to 2014' report. Information provided in this snapshot is produced by BC Stats for Destination British Columbia, and from Statistics Canada International Travel Survey.

TOURISM REVENUE

Total tourism revenue

Tourism revenue measures the money received by businesses, individuals, and governments due to tourism activities. In 2014, the tourism industry generated \$14.6 billion in revenue, a 5.1% increase over 2013, and a 37.7% increase from 2004.

2014 tourism revenue by sector




Provincial tax tourism revenue

Tourism-related provincial tax revenue was \$825 million in 2014, a decrease of 7.6% over 2013, and an increase of 13.2% since 2004. The decrease was due to British Columbia's transition from the Harmonized Sales Tax (HST) to the Provincial Sales Tax (PST) on April 1, 2013.

Tourism export revenue

In 2014, tourism exports generated revenue of \$3.9 billion, an increase of 3.7% over 2013. Tourism export revenue was similar to that of the mineral (\$4.6B) and agriculture and fish (\$3.2B) primary resource industries, but lower than that of forest products (\$12.4B) and energy products (\$7.8B).



Tourism gross domestic product

GDP for the provincial economy as a whole grew 2.9% over 2013. The tourism industry contributed \$7.1 billion of value added to the BC economy, as measured through GDP (in 2007 constant dollars). This represents 4.5% growth over 2013 and 13.1% growth since 2007. In 2014, tourism contributed more to GDP than the forestry and agriculture and fish primary resource industries but less than the mining, oil and gas extraction industry.

TOURISM BUSINESSES AND EMPLOYMENT

Tourism businesses**

In 2014, 18,682 tourism-related businesses were in operation in BC.

Tourism employment

In 2014, 127,500 people were employed in tourism-related businesses, a 2.2% increase over 2013 and a 18.4% increase since 2004.

Tourism wages and salaries

In 2014, the tourism industry paid \$4.3 billion in wages and salaries, up 4.5% from 2013, and a 30.3% increase since 2004. Average compensation in the tourism industry in 2014 was \$34,000, up 2.2% from 2013 and 10.0% since 2004.
